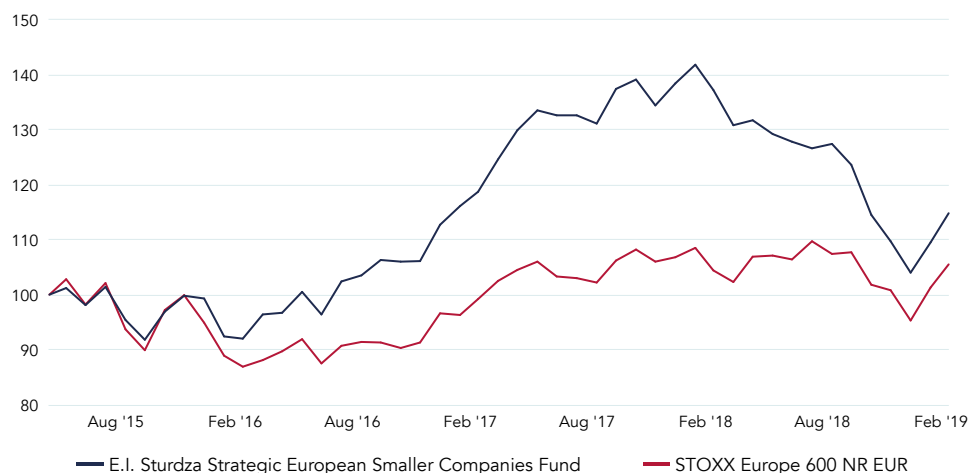
INVESTMENT APPROACH

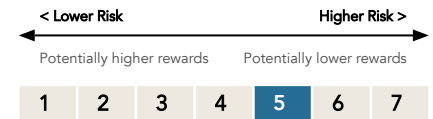
